

SPORTING REGULATIONS OF THE VAR PROVENCE VERTE MARATHON 2026

Version updated on September 21, 2025.

PREAMBLE

Organization : CREASPORTS ORGANIZATION, Association Law 1901, SIRET number 423935212 whose registered office is in HYERES (83400), France, 3 Impasse des Anémones the Association CREASPORTS ORGANISATION is hereinafter referred to as the Organizer

The terms “ you ” “ your ” and “ yours ” refer to you , as the participant or consumer , or to their parent or legal guardian (over 18 years old) if that participant or consumer is a minor in their country of residence .

Participation in the Event implies your express and unreserved acceptance of the General Conditions of Sale and the Regulations.

This document supplements the Conditions of Use of the online registration platform called NJUKO , accessible at the address : njuko.net

In the event of a contradiction between the terms of the njuko.net Conditions of Use , these General Conditions of Sale and the Regulations , the terms of the Regulations shall prevail over the General Conditions of Sale , which shall themselves prevail over the njuko.net Conditions of Use .

The Organizer may revise and update the General Terms and Conditions of Sale and the Regulations at any time; please consult them regularly. Any changes that are made will apply immediately upon being notified, by any means, including by publishing a revised version of these terms and conditions on the Event website marathon-var-provence-verte.com

In the event of a significant change to the General Conditions of Sale and/or the Regulations, the Organizer will endeavor to notify you by email.

Important! Role of the njuko.net website

Njuko.net, through which you registered, allows professional organizers to list and sell their products and services. Although the njuko.net platform facilitates transactions made on it, njuko.net is not the seller or organizer of the products and services related to the Event.

Accordingly , for the sale of products or services relating to the Event , a sales contract is formed solely between you and the Organizer . The Organizer is responsible for sales of products or services relating to the Event and for any claims or any other issues arising out of or related to the sales contract between you and the Organizer .

I. SPORTING REGULATIONS

These sporting regulations (hereinafter the Regulations) apply to all participants in the Event . They form an integral part of the General Conditions of Sale referred to above. In the event of conflict with the provisions of the General Conditions of Sale , the provisions of the Regulations shall prevail .

1.1. THE COURSES

The Event routes are respectively:

- 10.7km, 21.1km and 42.195km roads and country lanes, in accordance with the international road racing regulations (IAAF and FFA). The marathon can be run in relay teams of 2 or 5. The*

- Duo Run and bike formula will be held over the marathon distance. New Trail of approximately 20km. (Course being finalized)*
- *The Marathon Hike Approximately 10km on the heights of Brignoles*
 - *The walking tour for children will be 1 to 2 km.*

PROGRAM:

MAY 1, 2026:

5:00 p.m. Start of the Var Provence Verte Trail and the Marathon Hike

MAY 2, 2026:

9:00 a.m. Start of the Individual Marathon, Run and Bike and Relay Marathon in Chateauvert

10:00 a.m. Start of the Half Marathon in Carcès

10:40 a.m. Departure of the 10.7 km in Vins sur Caramy

1.2. CONDITIONS OF PARTICIPATION – LICENSE – MEDICAL CERTIFICATE

To participate in the Event, you must be at least:

- *16 years (sixteen) at the latest on December 31, 2026 for the 10.7km*
- *18 years old (eighteen) at the latest on December 31, 2026 for the half marathon, Run and Bike.*
- *20 years (twenty) at the latest on December 31, 2026 for the solo marathon runners.*
- *16 years (sixteen) at the latest on December 31, 2026 for the Team Relay marathon (5 runners but only on the two shortest relays)*

The age categories will give rise to a separate classification in agreement with the FFA. It is recalled that controls will be carried out during the Event to ensure perfect conditions of regularity of race in particular with regard to the conditions of age and medical certification .

By participating in the Event , you are participating in one of the sporting events organized or approved by the sports federations . Consequently , your participation is subject to the mandatory presentation of :

- *a sports license bearing attestation of the issue of a medical certificate stating the absence of contraindication to competitive athletics (FFA). FFTRI licenses are no longer accepted for participation in FFA races since 1/1/2019 .*
- *for non-licensed athletes to whom these competitions are open, the presentation of a PPS (Health Prevention Course , document to be completed online on the FFA website - <https://pps.athle.fr>)*

ATTENTION! Participants residing abroad : *You are required to provide a medical certificate stating that there are no contraindications to the practice of competitive athletics or competitive running , even if you hold a competition license issued by a federation affiliated with the IAAF . This certificate must be dated , signed and allow for authentication by the doctor , whether or not the doctor is established in France . If the doctor is foreign , the medical certificate must be written in French or English .*

Mandatory Mention on the Medical Certificate : *It is specified that your medical certificate must include the words " no contraindication to the practice of competitive athletics " or " no contraindication to the practice of competitive running " . FSCF , FSGT and UFOLEP competition licenses are accepted if they specifically state " athletics " . Other licenses cannot be accepted .*

FFA members will benefit from an automatic check of their license when registering online . If the online form validates your FFA membership, there is no need to insert your license. Other documents submitted online on the Sportips.fr website will be checked . You will receive an automatic message informing you whether your document is validated or invalidated . Authenticity checks of medical certificates and licenses may be carried out on site.

1.3. COLLECTION OF BIBS

Bibs will be collected upon presentation of the following documents:

- Your license, PPS or medical certificate for foreigners meeting the conditions referred to above,*
- Your ID .*

Bibs can only be collected at the Marathon Village located in Brignoles 83170, on Friday, May 1, 2026 from 12 p.m. to 7 p.m. and on Saturday, May 2, 2026 before the start . The bib must be fully legible during the race, including in bad weather .

A person will be able to collect their team bibs if all team documents are up to date and copies of identity cards are presented.

The price of the bibs is expressed in this document in Euros, all taxes included, at the rate in effect on the day of your registration.

Any registration for an Event is personal, firm and definitive, and cannot be refunded for any reason whatsoever.

Runners have the option of taking out cancellation insurance at the time of their registration. Please note that without this insurance no reimbursement will be made.

Each registration entitles you to one bib. No transfer of bibs is permitted for any reason whatsoever.

Any person returning their bib to a third party will be held responsible in the event of an accident occurring or caused by the latter during the event.

The organization declines all responsibility in the event of an accident in this type of situation.

When registering as a team, the name of the team members can be changed free of charge until April 20, 2026. After this date, changes will be possible until May 1, 2026, but at a cost of € 10 per name changed. No changes will be allowed on May 1 and 2, 2026.

Club, CE, group commitment:

Please note that you will need to identify a group leader and it is he or she who will collect the bibs and supplies for the entire group.

When creating the group, and from the first registration, the leader will receive a link with which he/she can add runners over the weeks.

He/she will also be able to forward this link to people in his/her group so that they can add themselves.

1.5. OFFICIAL JURY

It is composed of a race director, whose decision-making power is final. He is assisted by judges and race stewards. Refreshment points are set up approximately every 5 km as well as at the finish. Participants will have a maximum time of 6 hours to complete the 42.195 km course and 4 hours for the Half Marathon. After the passage of the end-of-race vehicle, participants must comply with the traffic rules of the highway code.

1.7. GENERAL SERVICES

Road safety is ensured by the markers and the police, and the medical service by the Civil Protection. They can decide to disqualify a participant from the race for medical reasons .

1.8. ACCESS TO THE SITE AND SECURITY

The introduction onto the Event site of any objects that may be dangerous or illegal, including drugs, firearms, blunt objects and explosive materials, is strictly prohibited.

To access the site and participate in the Event , the participant expressly acknowledges and accepts that the Organizer may call upon security personnel who will be authorized to check both people and their personal belongings. Any person wishing to access the site agrees to submit to this check . In the event of refusal, the person will not be authorized to access the site . The Organizer and security personnel are authorized to refuse access to the Event or the continuation of the race to participants whose behavior is likely to disrupt the smooth running of the Event , including but not limited to the following: introduction of any object that could potentially hinder in any way the progress of the race , traffic and/or the safety of other participants ; introduction of any distinctive sign promoting, in any form whatsoever, a political , philosophical or religious opinion likely to harm the image of the Event .

1.9.1 TIMING

All participants will be given an electronic chip when collecting their bib (a chip in the form of a strip stuck behind each bib) which will be automatically initialized on the starting line and will serve as a race regularity check at several points along the course. A participant not using the roadway of the course will not be classified at the finish .

Regarding the relay marathon of 5 or 2 runners, the passage of the bib positioned on the bib holder will be obligatory in order to ensure the timing of each relay runner and to establish the overall timing of the 42.195 km .

their respective bibs must cross the course checkpoints and the finish line together .

The electronic detection system is selected according to strict reliability criteria. Despite tests conducted by the manufacturers, there is still a very low percentage of non-detection. The lack of data resulting from this non-detection means we have a system that records all arrivals and we can reclassify them if necessary.

As the departure points are different from the arrival site , shuttles are organized to take you to the departure points . See specific Shuttles tab*

TRANSPORT:

Shuttle buses will be scheduled to take you to the departure site . You will find all the information and timetables on the website in the " Shuttles - Instructions " tab .

- MARATHON VAR PROVENCE VERTE TEAMS OF 5 :

The “ relay ” event will follow the route of the “ individual ” event of the Var Provence Verte Marathon.

Team Member 1 Relay 1 » Chateauvert > Correns : 8.5 km

Teammate 2 Relay 2 » Correns > Montfort : 5.5 km

Team 3 Relay 3 » Montfort > Carces: 7.0 km

Team member 4 Relais 4 » Carces> Wines : 13.6 km

The start of the relay event will be given simultaneously with the start of the individual Marathon event on May 2 , 2026 at 9:00 a.m.

The finish will be judged at Cours Liberté in Brignoles . The route of the event can be viewed in the “ Events ” tab on the event website .

Bibs : When the bibs are handed out, each team will be given 5 individual bibs (to be worn on the back) plus one bib (to be worn in front). This will be attached to a bib belt and will be used as a baton during the relay between team members.

TRANSPORT:

Shuttle buses will be scheduled to take you to the departure and relay point sites . You will find all the information and timetables on the website in the " Shuttles - Lockers " tab .

- MARATHON VAR PROVENCE VERTE TEAMS OF 2 :

The " relay" event will follow the route of the " individual " event of the Var Provence Verte Marathon . Relay carried out in Carcès at the half marathon.

The start of the relay event will be given simultaneously with the start of the individual Marathon event on May 2 , 2026 at 9:00 a.m.

The finish will be judged at Cours Liberté in Brignoles . The route of the event can be viewed in the " Events " tab on the event website .

Bibs : When the bibs are handed out, each team will be given 2 individual bibs (to be worn on the back) plus one bib (to be worn in front). This will be attached to a bib belt and will be used as a baton during the relay between the team members.

TRANSPORT:

Shuttle buses will be scheduled to take you to the departure and relay point sites . You will find all the information and timetables on the website in the " Shuttles - Lockers " tab .

- RUN AND BIKE MARATHON:

A mountain bike for two (electric mountain bikes not permitted)

Wearing a helmet is mandatory on the bike

The two team members must stay close together (10m maximum)

Procedure:

Only one team member will start the marathon at 9:00 a.m. The other team member will wait for their partner a few kilometers later in the village of Correns. From this junction point, they will complete the course in pairs and make changes (runner / cyclist) as they wish. You must cross the finish line and the checkpoints together to be classified .

Bibs : When the bibs are handed out, each team will be given 2 bibs to wear at the front.

TRANSPORT:

Participants in the Run and Bike Marathon will have to travel to Chateauvert on their own, and will be able to park their vehicles. The runners will start with the Individual Marathon and Marathon Relay; the cyclist will have to travel to Correns by bike and will wait for their partner at this junction point.

After the test , shuttles will be set up between the arrival in Brignoles and your vehicle in Chateauvert . You will find all the information and timetables on the website in the " Shuttles - Lockers " tab .

TRAIL VAR PROVENCE VERTE

A water reserve of at least 1.50l.

Rain gear in case of bad weather.

THE MARATHON HIKE:

No medical certificate is required for your commitment.

A refreshment station halfway through.

A minimum water reserve of 50cl.

Rain gear in case of bad weather.

1.10. INSURANCE

Civil Liability: In accordance with current legislation, the Organizer has taken out insurance covering the financial consequences of its civil liability, that of its employees and all participants in the Event. With regard to the civil liability of participants, the intervention of this insurance for the latter is limited to accidents that they may cause during the running of the Event. This guarantee will intervene in addition to or in the absence of other insurance from which the participants may benefit elsewhere. Proof may be provided to any participant upon simple request.

Personal accident: the organization recommends that all participants who do not have personal insurance covering their bodily injuries, particularly those not licensed with a sports federation, take out personal accident insurance as part of their participation in the event.

THIS INSURANCE IS OPTIONAL BUT STRONGLY RECOMMENDED. It can be taken out in addition to or in lieu of similar insurance, particularly through a sports license. The information notice and membership form are available on the Event website (Registration -> Insurance)

Material damage : The Organizer declines all responsibility in the event of damage (theft, breakage, loss, etc.) suffered by the personal property of participants, even if it is in its custody. Participants will therefore not be able to turn against the Organizer for any damage caused to their equipment . It is the responsibility of each individual to take out insurance covering these risks .

1.11. USE OF IMAGES

1.11.1. Participant image:

The Event may be subject to recording for the purpose of communication to the public, in any form (including photo, video , etc.), on any existing or future medium , in any format, for any communication to the public worldwide, for any use including advertising and/or commercial purposes, each participant expressly authorizes the Organizer , its beneficiaries or assigns (including its commercial partners) to fix and reproduce, on any medium and by any means, and consequently, to reproduce and represent , without remuneration of any kind, its names, voices, images, and more generally its sporting performance within the framework of the Event (hereinafter " its Image ") , for a period not exceeding 10 years following the date of the Event . The participant expressly authorizes the Organizer to grant to the Event 's partners sub - licenses to exploit his Image for commercial and advertising use of the Image .

To this end, each participant expressly and irrevocably authorizes the Organizer, its beneficiaries, its successors in title (in particular its commercial partners), in order to meet the requirements of advertising, promotional and/or commercial campaigns to:

- 1) make any modification, addition, deletion, which it deems useful for the exploitation of its Image under the conditions defined above,*
- 2) associate and/or combine with its Image, all/all signatures, taglines, slogans, legends , brands , distinctive signs, legal notices , visuals and, in general, any element of any nature chosen by the Organizer intended in particular to illustrate the communication media in which they are integrated .*

The participant guarantees that he is not bound by any exclusive contract relating to the use of his Image.

The participant is informed and accepts without reservation that his/her participation in the Event involves the capture of his/her Image by the Organizer's official service providers . His/her Image reproduced in photo and/or video format will be accessible on the sportips.fr website in the "My Account" area and for one year on the Event website in the "Results " section . Regarding the Event website , the participant accepts that he / she may be identified by any internet user by his /her name, first name , bib number and region .

1.11.2. Images of the Event:

Any communication of still images and/or animated sequences of the Event captured by the participant during their participation in the Event must be limited to personal use and may not under any circumstances be used for promotional and/or commercial purposes outside the Event.

1.12. PERSONAL DATA

In general , the personal data communicated by the participants (hereinafter “ the Data”) are intended for the authorized personnel of the Organizer , which is the company responsible for processing this data .

To learn about the Organizer's Data Protection Policy, please refer to the General Terms and Conditions of Sale (I). As an Event Participant, we also invite you to read the following provisions carefully:

You acknowledge that any user of the live tracking application or the internet may be able to track participants in the Event by entering their name and/or first name and /or bib number .

At the end of the Event , information relating to your sporting performance (including your results , photos and videos) will be published on the Event website . Your results may be used by any media .

If you wish to object to the publication of your first and last names in the rankings, this is possible, but this action must be declared to the FFA, and is definitively irreversible for all your future FFA races.

If you wish to oppose such publication for a legitimate reason , you must communicate this decision to the Organizer at CREASPORTS ORGANISATION 3 Imp des Anémones , 83400 Hy è res before the Event and at the latest 20 days before the latter so that the appropriate measures can be taken.

1.13. AERIAL IMAGE CAPTURES

Participants are informed that:

- On the day of the Event , drones may be used for filming purposes ;*
- They may be located, during all or part of their participation in the Event, within 30 meters of said aircraft.*
- If necessary , safety instructions will be communicated to them and must be strictly observed .*

1.14. RESPECT FOR THE ENVIRONMENT

You are participating in an ECO MARATHON, we are putting in place numerous measures to ensure that the event is as " clean as possible " . In order to respect the environment and the natural spaces crossed , it is strictly forbidden to leave waste (paper, plastic packaging, etc.) on the course. We prohibit the use of amateur and professional drones on the course and near the event.

When you collect your race numbers you will be given a cup (light and foldable), which you will need to run with to be able to refuel.

THERE WILL BE NO OTHER CUPS ON THE COURSE AND AT THE FINISH

Bins will be available at each refreshment station and “ collection zones ” will be installed and marked at various points along the route. They must be used by participants .

Participants must keep waste and packaging while waiting for the places indicated by the Organizer to dispose of them .

The Organizer reserves the right to award time penalties or to disqualify participants or their team who voluntarily throw their waste outside the designated areas .

1.15. EQUIPMENT PROHIBITED ON THE COURSE

Bicycles (excluding Run and Bike participants), rollers and/or motorized vehicles are strictly prohibited on the course.

1.16. ANTI-DOPING FIGHT

The Event may be subject to anti-doping controls. Participants in the Event undertake to strictly comply with the ban on doping and the provisions concerning anti-doping controls, as they result from the laws and regulations in force, in particular Articles L.230-1 et seq. of the Sports Code.

1.17. MODIFICATION – POSTPONEMENT – CANCELLATION

If circumstances require it, the Organizer reserves the right to modify at any time the route, the position of the refreshment points and the time points, and to postpone the date and/or times of the Event.

If the Event should be cancelled for any reason beyond the control of the Organizer presenting the characteristics of force majeure, the latter will propose , depending on the circumstances, compensation such as substitution by a postponement of the Event or the transfer of the bib to the following edition .

II. GENERAL CONDITIONS OF SALE

If you have ordered , whether paid or free of charge, a product or service of the Var-Provence Verte Marathon from the Organizer via the njuko.net website (its website, its mobile site or its application) then these General Conditions of Sale apply to you and constitute the sales contract which binds you to the Organizer .

Furthermore, if you participate in the Event as a runner, the Regulations also apply to you.

2.1. SCOPE OF APPLICATION
